

XBOX® ANT-MAN AND THE WASP SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES, THE DISTRICT OF COLUMBIA, PUERTO RICO, AND CANADA (EXCLUDING QUEBEC) WHO ARE THIRTEEN (13) YEARS OLD OR OLDER AT THE TIME OF ENTRY. MANY WILL ENTER, FEW WILL WIN.

The Xbox Ant-Man and the Wasp Sweepstakes ("Sweepstakes") is sponsored by Microsoft Corporation, One Microsoft Way, Redmond, WA 98052 ("Sponsor") and is administered by Prize Logic, LLC, 25200 Telegraph Road, Suite 405, Southfield, MI 48033 ("Administrator").

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins October 1, 2018 at 12:00:00 PM Eastern Time ("ET") and ends October 21, 2018 at 11:59:59 PM ET ("Sweepstakes Period"). Administrator's computer is the official clock of the Sweepstakes.
- 2. ELIGIBILITY:** The Sweepstakes is offered only to legal residents of the fifty (50) United States, the District of Columbia, Puerto Rico, and Canada (excluding Quebec) who are at least thirteen (13) years of age at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, Buena Vista Home Entertainment, Inc., and each of their respective parent companies, subsidiaries, affiliates, and advertising, promotion and web design agencies (collectively, "Sweepstakes Entities") and members of the immediate family (mother, father, brothers, sisters, sons, daughters and spouse, regardless of where they reside) and household members of each such employee, officer, director, representative or agent whether or not related, are not eligible to enter or win. Void in Quebec, all other United States Territories and Possessions and overseas military installations, and where prohibited or restricted by law. All federal, state, provincial, territorial, and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. If it is discovered or suspected that an entrant has registered or attempted to enter the Sweepstakes using multiple e-mail addresses or multiple identities, all of that entrant's entries will be declared null and void and any prize that entrant might have been entitled to receive or win will not be awarded. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any entrant attempting such use. If an entrant participates via a mobile device, message and data rates may apply. Not all cellular telephone providers carry the service necessary to participate in the Sweepstakes through a mobile device. Entrants should check their mobile devices' capabilities and wireless service pricing plans.

3. **HOW TO ENTER:** During the Sweepstakes Period, an eligible entrant must visit AntManWaspXboxSweeps.com (“Website”) and submit his/her date of birth and ZIP/Postal Code then his/her valid e-mail address. The eligible entrant must then follow the instructions to register by entering all information requested on the registration form including, but not limited to, his/her complete first and last name (no initials), complete residential address (P.O. Boxes are not accepted), city, state/province, ZIP/Postal Code, date of birth, phone number, and confirmation that entrant has read and agrees to be bound by these Official Rules. Upon successful registration, the entrant will receive one (1) entry into the Sweepstakes.

Every day thereafter during the Sweepstakes Period, the entrant may return to the Website and enter his/her e-mail address to obtain one (1) additional entry into the Sweepstakes.

Entry Limit: Limit one (1) entry per entrant per day during the Sweepstakes Period. A “day” is defined as starting at 12:00:00 AM ET and ending at 11:59:59 PM ET on a calendar day, except October 1, 2018, when a day is defined as starting at 12:00:00 PM ET and ending at 11:59:59 PM ET. If entries are submitted in excess of the limits, all of that eligible entrant’s entries may be deemed invalid, at Sponsor’s sole discretion.

4. **RANDOM DRAWING:** On or about October 22, 2018, Administrator will randomly select five (5) potential winners from among all eligible entries received during the Sweepstakes Period. Each winner is deemed to be a potential winner pending verification of his/her eligibility and compliance with these Official Rules, as determined by Sponsor, at Sponsor’s sole discretion. A Canadian resident will be required to correctly answer a timed mathematical skill-testing question, as further described in Section 6 of these Official Rules, before being declared a potential winner.

5. **PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE (“ARV”):**

A. **Prizes (5):** Each winner will receive a custom Xbox One X Console and 4K Disc of the *Ant-Man and the Wasp* (“Prize”). Five (5) Prizes will be available in the Sweepstakes. The ARV of each prize is \$525 USD/ \$678.03 CAD.

B. **Total ARV:** The total ARV of all available Prizes in the Sweepstakes is \$2,625 USD/\$3,390.17 CAD.

C. **Odds of Winning:** The odds of winning a Prize depend on the number of eligible entries received during the Sweepstakes Period.

D. **General Prize conditions:** Prizes cannot be transferred and resale is prohibited. No Prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a Prize or force majeure. Each winner shall be solely responsible for payment of any and all applicable federal, state, provincial, territorial, and local taxes for any Prize won. All other costs and expenses not expressly set forth herein shall be solely the winner’s responsibility. The Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. Each Prize will only be awarded to a verified winner. Limit one (1) Prize per person/household. Currency conversions based on listed exchange rate as of September 24, 2018.

6. **HOW TO CLAIM A PRIZE:** Each potential winner is subject to verification of eligibility and compliance with the Official Rules. After the random drawing, Sponsor’s designee will notify

each potential winner via e-mail at the e-mail address he/she used to register for the Sweepstakes with instructions on how to claim a Prize. If a potential winner is a Canadian resident, before being declared a winner, he/she will be required to correctly answer a timed mathematical skill-testing question without assistance, which will be provided with the e-mail notification or the prize will be forfeited. Failure to provide all required information (and correctly answer the skill-testing question, for a Canadian resident) within the timeframe communicated in the winner notification may result in forfeiture of a winner's right to claim a Prize, and may result in the Prize being awarded to an alternate winner selected at random, if time permits. Prizes will be mailed to winners at the residential addresses provided at registration approximately six (6) to eight (8) weeks after winners are verified. If, after a good-faith attempt, Sponsor is unable to award or deliver a Prize, the Prize will not be re-awarded.

In the event that, due to technical, typographical, mechanical or other errors, there are more winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winners. due to technical difficulties or incorrect announcements of any kind, more winning messages are distributed, or more prizes are claimed than are intended to be awarded for any prize according to these Official Rules, the intended Prize will be awarded in a random drawing from among all verified prize claims received for that prize. This Sweepstakes is subject to all federal, state, provincial, and local laws and regulations.

IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY JAMS IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF (“JAMS RULES”). THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN MICHIGAN. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN OAKLAND COUNTY, MICHIGAN. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY’S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION ACCRUED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.
